Rules: Play Smart Gift Smart School Supply Drive

Drawing Dates

Seven (7) Play Smart Gift Smart School Supply drawings (“Drawings”) will be conducted by the North Carolina Education Lottery (“NCEL” and/or “Sponsor” and/or “Lottery”) for the “Play Smart Gift Smart School Supply Drive” Drawing Promotion (“Promotion”). Winners

As outlined above, at the conclusion of the Promotion entry period seven (7) Drawings will occur as part of this Promotion. Five (5) winners will be selected in each drawing; in sum, the Promotion will have a total of thirty-five (35) winners. The NCEL reserves the right, in its sole discretion, to substitute any prize with an alternate prize of equal or greater value. The total estimated retail value (“ERV”) of all prizes is \$10,500.00.

Entry Eligibility Requirements

A valid entry shall follow the entry requirements herein and require players to enter one entry into any or all of the seven promotional drawings. Players may (i) enter up to one entry into each of the six NCEL office promotional Drawings by submitting a Promotion entry form via a QR code found at the NCEL claims offices, and/or (ii) enter the online promotional Drawing by submitting the entry form at ncplaysmart.com/play-plus-ups/playsmartgiftsmart. Entrants will only receive one entry per Drawing regardless of number of times entered via the entry form.

1. For Drawings at each of the six NCEL regional office and claim centers, players may enter by visiting any NCEL regional office and claim center, receiving the Promotion entry form URL (through a QR code provided by a claim center representative), and submitting the online entry form.

2. For the online Drawing, players may enter by visiting ncplaysmart.com/play-plus-ups/playsmartgiftsmart and submitting the online entry form.
 - The NCEL and its vendor(s) will not be responsible for data entry errors by entrants nor for connectivity issues involving the player's access to the NCEL's website.
 - The NCEL reserves the right to disqualify any entry submitted without the proper entry requirements.
3. Entrants must be at least eighteen (18) years old to participate in this Promotion.
4. Entrants are subject to all NCEL Rules and Regulations, the North Carolina State Lottery Act, all other applicable laws, NCEL Terms of Service and Use, and the drawing procedures for this Promotion. This Drawing Promotion and/or any parts thereof, including the award of any prizes, is void as may be prohibited by law.

Employees of the North Carolina State Lottery Commission d/b/a NC Education Lottery, Aristocrat Leisure Limited, Pollard Banknote Limited, Scientific Games, LLC, IGT Global Solutions Corporation, Spurrier Group, Brkthru Digital, LLC, MDI Entertainment, LLC, McConnell & Jones LLP, Cactus Communications, Inc., NeoPollard Interactive LLC and excluded members of their respective households, are prohibited from participating in this Promotion. This prohibition shall also apply to any employees, and excluded members of their respective households, of companies that are associated with the game development and/or drawing process in any way. 6. **The utilization of region-specific QR codes located at NCEL Offices and/or the NCEL online entry form the only methods of entry into this promotion. Entries sent via any other method, such as US mail/courier, drop-off, etc., will not be accepted.**
7. Entries utilizing an approved method described herein are valid for one (1) official Drawing entry pursuant to this Promotion. Players may only submit one (1) entry per Drawing. If any player submits more than one entry per Drawing, all subsequent entries for that Drawing will not be accepted. Players may win only one prize pursuant to this Promotion. The NCEL reserves the right to modify the drawings available for participation at any time for any reason. The odds of an entry being selected to win a prize in each drawing depend upon the number of entries received for each drawing. Drawing entries are eligible for one drawing only, unless otherwise specified in the specific drawing rules. An Entrant may win no more than one prize in any drawing.
8. The NCEL reserves the right to modify the Drawings available for participation at any time for any reason. The odds of an entry being selected to win a prize in each Drawing depend upon the number of entries received for each Drawing. Drawing entries are eligible for one Drawing only. At least 3 attempts will be made to contact the selected entrants by email, phone call, and/or other methods of contact at the discretion of the NCEL. If winners fail to claim their prize within the thirty (30) calendar day period, the NCEL will select a replacement winner from the Drawing alternates.
